## **Application Instructions**

#### All Applications are Due February 24, 2025.

All vendors must fill out an application every year. For existing members, this helps us keep our information as up-to-date as possible. The board of directors will review all applications and present them at the annual meeting for final approval. Please complete the application for membership to the Concord Farmers' Market by February 24, 2025. The annual membership fee for a full-time member is \$25 and shall be included with this application. Guest vendors are not eligible for membership.

### **Existing Vendors**

The board will review existing members applications to ensure the following:

- Existing information on file is up-to-date
- Approve new products requested by existing vendors

Anticipated dates of attendance: Do the best you can at the date of this application to indicate dates you will NOT be attending. This allows for better planning on the board's part.

#### Stall Fees\*

Stall Fees as per by / laws and rules will be determined at the annual meeting. A separate bill for fee increases will be sent after the meeting. Stall fees are discounted 10% if you pay for all of the markets prior to the start of the market season (May 4, 2025). Fees paid on Market day are weekly at full price. Please have payment ready by 10 a.m. on market days.

#### **Prospective New & Guest Vendors**

The board will review prospective new and guest vendors applications and present vendors that meet the following criteria:

- Distance of the vendor is 25 miles from the market unless exceptions are made.
- Products to sell are 75% agricultural
- Products do not conflict with existing vendors

Please Note: Guest vendors are not members of the market and do not have voting rights or other benefits of membership.

#### Market Attendance\*\*

- **Full Time Members** accepted individuals are considered Full Time members of the market only if they participate in 75% (20 out of 26) of the market days each year unless otherwise approved by the board.
- **Guest Vendors** Individuals not attending 75% (20 out of 26) of market days shall be considered guest vendors, and allowed in the market as space allows space determined by the board. There are no set schedules for guest vendors. The Guest Vendor Coordinator will contact you with dates prior to the beginning of the market season, taking into consideration the desired dates on the guest vendor application.

#### **Insurance**

All vendors are required to have and provide proof of Liability insurance. (A copy of the certificate of insurance is acceptable). Please provide this with your application or at the very latest before you plan to attend the market. You will not be able to attend the market without insurance.

#### Agreement to Market Terms, Rules and Bylaws

As a member of the Concord Farmers' Market, I/we agree that prior to offering any products for sale at the market, I/we, will become familiar with the Concord Farmers Market rules and bylaws, NH State Regulations and City of Concord rules pertaining to my product, including USDA organic certification, USDA meat inspection regulations / certifications, NH Weighing device rules / certifications. I/we agree to comply with the provisions of these documents. I/we understand that individual product liability is my responsibility, and I/we will provide a copy of my/our liability insurance certificate with my application. If the policy's anniversary date falls during the market I/we will provide a copy of the renewed policy at that time. I do hereby release the Concord Farmers Market Association, the Concord Farmers Market Board of Directors, and the City of Concord from liability due to my participation in the market.
